

### Axle-Back Exhaust System Installation Instructions

Thank you for making FLOWTECH EXHAUST your choice in a high-performance exhaust system. Extensive dyno/track testing has enabled FLOWTECH to offer the most advanced design in exhaust systems. The installation, while not complex, will take a certain amount of time. However, the additional horsepower and improved performance will more than justify your efforts. Proper installation and maintenance will ensure long life and maximum performance from your FLOWTECH Axle-Back exhaust system.

### **BEFORE STARTING:**

Your vehicle must be raised a minimum of 36 inches. A floor hoist is ideal. If no hoist is available, we strongly urge the use of axle stands as a safety measure. Please read these instructions in their entirety before attempting installation.

# CAUTION! WORK ONLY ON A LEVEL SURFACE. USE JACKS /JACK STANDS OF SUFFICIENT CAPACITY TO LIFT AND SUPPORT YOUR VEHICLE. NEVER WORK UNDER A VEHICLE SUPPORTED BY A FLOOR OR BUMPER JACK.

#### INSTALLATION:

- 1. Disconnect the negative cable from the vehicle battery.
- 2. Lift the vehicle and secure on jack stands.
- 3. From under the vehicle, use a permanent marker to mark the left and right side OE mid pipe directly under the end of the suspension cross member (located after the crushed section of the OE mid pipe). Use masking tape to wrap around the OE mid pipe where your permanent marks are to ensure a straight cut. Draw arrows to ensure you cut at the correct side of the marking tape. DOUBLE CHECK AND MEASURE TWICE BEFORE CUTTING.

- 4. When complete, de-burr the inside and outside of the cut tube. CAUTION! BE CAREFUL AS THE CUT ENDS WILL BE VERY SHARP.
- 5. Remove (x4) 15mm head nuts securing the left and right side rearmost aluminum hanger brackets off the vehicle.
- 6. Slide the (x2) rubber isolation mounts off the vehicle and then the (x2) aluminum hanger brackets. Remove OE axle-back exhaust.
- 7. On a workbench, remove the (x2) rubber isolation mounts and then the (x2) aluminum hanger brackets off the OE axle-back exhaust and transfer onto the FLOWTECH Axle-Back Exhaust System. We recommend transferring the isolation mounts and aluminum brackets one a time to ensure they go to the appropriate locations.
- Using (x2) 2.25" band clamps, slide the left and right side FLOWTECH axle-backs (approximately 2.0" engagement) onto the OE mid pipe and secure the (x2) rubber isolation mounts on the vehicle and the (x2) aluminum hanger brackets using the (x4) 15mm head nuts removed from step 5 and tighten. Do not tighten the band clamps.
- 9. Align the FLOWTECH Exhaust Axle-Back Exhaust System including the left and right side tips to your desired position and tighten the (x2) band clamps from step 8.
- 10. Connect the battery, start the engine, and check for leaks.
- 11. Re-check your work.
- 12. Remove the jack stands and lower the vehicle.
- 13. After 150 miles, re-check and tighten all bolts and clamps.

## NOTE: It is normal for the FLOWTECH Axle-Back Exhaust System to emit smoke for the first few minutes during break-in period.
